Exhibit E: Iowa Campus Compact / Corporation for National and Community Service Grant

It was moved by Ms. Flynn and seconded by Ms. Johnson that the Board of Education accept with gratitude the grant from Iowa Campus Compact/Corporation for National and Community

Service in the amount of \$24,800 to fund eight AmeriCorps/VISTA positions for the 2018 Summer Academy. Adriane Carlson, Irving Elementary At-Risk Student Support Coordinator, and Darren Hanna, Director of Elementary Education, provided information. Motion carried 5-0.

VIII. Resolution in Support of Iowa Public Education

It was moved by Mr. Knight and seconded by Ms. Johnson that the Board of Education approve the Resolution in support of Iowa Public Education. Shanlee McNally and Dr. Jane Lindaman provided information, and all board members were given the opportunity to comment. Motion carried 5-0.

RESOLUTION IN SUPPORT OF IOWA PUBLIC EDUCATION

WHEREAS, the legislature will look at enacting Educational Savings Accounts; and

WHEREAS, the Board, in consultation with its community, has determined that the Iowa legislature should not enact educational savings accounts as currently proposed, or vouchers, and should continue to promote and fully invest in Iowa's public schools, more specifically:

- Iowa already has school choice options like open enrollment, virtual education, home schooling (both competent private instruction and independent private instruction), and tuition tax credits for private schooling;
- Public schools are overseen by locally-elected citizens and are required by law to operate with openness and transparency concerning expenditures, reporting and decision-making. Nonpublic schools are not held to that same standard.
- Policymakers should continue to promote cooperation and the collaborative environment that already exists between public and nonpublic schools; and
- Public schools accept and educate all students, regardless of background, socio-economic status, special needs, race, religion, etc.

WHEREAS, the Board believes that public schools provide a strong educational foundation for Iowa's children;

WHEREAS, educational savings accounts, if enacted as currently proposed, would jeopardize public school programs and opportunities by directing resources away from public schools to nonpublic schools who are not subject to the same standards for their use of taxpayer resources.

NOW, THEREFORE, be it resolved that the Waterloo Board of Education fully supports Public Education as specified above.

Passed and approved this 5th day of February, 2018.

IX. Property Exchange Agreement with City of Waterloo / Miriam's Park and Edison School Site

It was moved by Mr. Knight and seconded by Ms. Flynn that the Board of Education approve the Property Exchange Agreement with the City of Waterloo, transferring ownership of the former Edison Elementary School site to the City and receiving a 10-acre portion of Miriam's Park in exchange. Dr. Jane Lindaman and Shanlee McNally provided information. Motion carried 5-0.

X. Contract for Financial Audit Services

It was moved by Ms. Flynn and seconded by Ms. Johnson that the Board of Education accept the recommendation from the Finance Committee and approve the bid from BerganKDV, Ltd. of Waterloo, IA to provide independent financial auditing services for Fiscal Years 2018 through 2022. Dr. Jane Lindaman, along with Sue Flynn and Shanlee McNally, members of the Finance Committee, provided information. Motion carried 5-0.

- XI. Issuance of School Infrastructure Sale, Services and Use Tax Revenue Bonds, Series 2018

 It was moved by Ms. Flynn and seconded by Mr. Knight that the Board approve the Resolutions

 Directing the Sale of School Infrastructure Sales, Services and Use Tax Revenue Bonds, Series

 2018 as presented. Dr. Jane Lindaman provided information. Motion carried 5-0 on a roll call
 vote with Ms. Johnson, Mr. Knight, Ms. Flynn, Mr. Williams and Ms. McNally all voting yes.

 The following three resolutions were approved:
 - Resolution appointing Bankers Trust Company to serve as trustee, approving the trust indenture and authorizing the execution of same.
 - The form of tax exemption certificate be placed on file and approved.
 - Resolution authorizing and providing for the terms of issuance and providing for and securing the payment of \$16,667,000 School Infrastructure Sales, Services and Use Tax Revenue Bonds, Series 2018, of the Waterloo Community School District, State of Iowa, under the provisions of Chapters 423E and 423F of the Code of Iowa, and providing for a method of payment of said bonds.

XII. Superintendent's Report

Dr. Lindaman reported on the following:

- Ms. Carlson, in her Why Waterloo Schools presentation, stated "people give of their time when they believe in the mission" would like to thank board members for giving of their time and efforts in supporting the mission and vision of Waterloo Schools
- Urge the public to stay in tune with current legislation lots going on at the state level right now
