#### **BACKGROUND:**

May 30, 2018, is the deadline for each school district to amend and file its previously certified budget with the County Auditor and the Department of Education. A public hearing on the amendment is required. School Districts are required to publish a proposed budget summary at least ten days and not more than twenty days prior to the budget hearing date. The required notice of public hearing and the proposed budget amendment was published in the WCF Courier on May 3, 2018.

Chapter 24.9 of the Code of Iowa provides for the amendment and increase of certified budgets to permit appropriation and expenditure during the fiscal year covered by the budget of unexpended cash balances on hand at the close of the preceding fiscal year and to also permit appropriation and expenditure of cash anticipated to be available during the year which had not been previously estimated and appropriated for expenditure.

When the Board certified the 2017-18 District Budget, the following categories were set:

Instruction-	\$86,911,911
Total Support Services-	\$46,517,363
NonInstructional Programs	\$ 6,925,414
Other Expenditures	\$23,337,416

The following amounts are the recommendations to amend.

Instruction-	\$90,911,911	Increased Staffing Costs
Total Support Services-	\$48,517,363	Staffing Reclassification
NonInstructional Programs	\$ 8,925,414	Food Service Increases
Other Expenditures	\$33,337,416	Construction Projects in Progress

This change in estimates of expenditures will be financed from increased receipts and balances not budgeted or considered in the current budget. There will be no increase in taxes to be paid in the fiscal year ending June 30, 2018. At the hearing, any resident or taxpayer may present objections to, or arguments in favor of, any part of the proposed amendment. A detailed statement of additional receipts other than taxes, balances on hand at the close of the preceding fiscal year, and proposed expenditures, both past and anticipated, will be available at the hearing.

As in previous years, each of our schools' media centers will receive a new book as a symbol of our gratitude and a lasting tribute to our staff's commitment to students:

Pre-K buildings will receive <u>*The Digger and the Flower*</u>, written by Joseph Kuefler. The book delivers a powerful message about the environment, as "Digger" discovers something growing in the rubble and sets in motion a series of events that will change him and the city forever. It is on Brightly.com's "18 Must-Read Picture Books of 2018" list.

Elementary buildings will receive <u>After the Fall (How Humpty Dumpty Got Back Up Again)</u>, written by Dan Santat. Caldecott medalist Dan Santat's tale follows Humpty Dumpty, an avid bird watcher whose favorite place to be is high up on the city wall – that is, until *after* his famous fall. Now terrified of heights, Humpty can no longer do many of the things he loves most. This book is a reminder to readers that life begins when you get back up.

The motion carried 5-0 on a roll call vote with Ms. Johnson, Mr. Knight, Mr. Schmitt, and Ms. McNally all voting yes. The meeting went into closed session at 4:04pm.

The Board returned to Open Session at 5:04pm.

It was moved by Ms. Flynn and seconded by Ms. Johnson that the Board of Education of the Waterloo Community School District conclude that the basis for the recommendation of the administrative staff that the Hoover Middle School student be expelled for violation of the District's Student Conduct Code and because the presence of the student is detrimental to the best interests of the school, has been established and, therefore, that the Hoover Middle School student is hereby expelled from the Waterloo Community School District for the remainder of the 2017-2018 school year and the Board approve and accept the proposed Findings of Fact and Conclusions of Law as presented in closed session. Upon return of the student to Waterloo Schools after the recommended term of expulsion, the Board hereby imposes special Board provisions as follows:

- the student must undergo an evaluation by a qualified licensed mental health professional with a report of findings to be submitted to the Board and the Executive Director of Student and At-Risk Services;
- 2) the student must appear before the board for a re-entry hearing; and
- 3) placement of the student shall be determined by the Executive Director of Student and At-Risk Services.

Any violation of the special provisions imposed by this Board upon the return of the student shall be referred to the Board for further action. The motion carried 5-0 on a roll call vote with Ms. Johnson, Mr. Knight, Mr. Schmitt, Ms. Flynn and Ms. McNally all voting yes.

It was moved by Mr. Knight and seconded by Ms. Flynn that the Board of Education adjourn the meeting. Motion carried 5-0. The meeting adjourned at 5:07pm.

#### **BACKGROUND:**

Pursuant to Chapter 28E of the Iowa Code, the Waterloo Community School District wishes to enter into an agreement with Hawkeye Community College to provide students the opportunity of taking collegiate level coursework while in high school. The parties, for mutual consideration and benefits, agree to provide joint services on the terms and conditions hereinafter set forth.

The school board shall annually approve courses to be made available for high school credit using locally developed criteria (Senior Year Plus, 2016).

Locally developed criteria include:

- A variety of college and career options are available to provide opportunity for a diverse population of learners.
- The Hawkeye Community College concurrent courses are offered at four WCSD campuses; Elk Run, Waterloo Career Center, East High, and West High School.
- The Hawkeye Community College concurrent courses, at the Waterloo Community School District sites, are taught by high school instructors employed by the Waterloo Community School District who meet state and college faculty standards and requirements.

Statutory changes from 2017-2018 impacting course eligibility through the PSEO (post-secondary education option) program with Hawkeye Community College continue to be offered as concurrent

- The concurrent courses will continue to receive supplemental weighting.
- Students can take PSEO courses through UNI or various four-year institutions.

#### **BACKGROUND:**

AEA Purchasing is formed under the Code of Iowa as a 28E entity and is an initiative of <u>Iowa's</u> <u>Area Education Agencies</u>. The goal of AEA Purchasing is to combine the purchasing power of Iowa school districts to offer aggressive pricing on materials, goods and services. In 2017 participating Iowa schools and AEA's saved over \$7 million on their purchases through the program. Participation in AEA Purchasing is without cost to Iowa's schools in that it is funded by small fees paid by the vendors. This buying power allows for better pricing on food for the school district.

#### **BACKGROUND:**

On April 9, the board approved a program to equip all sixth through ninth grade students with a chromebook to be used as a tool to enhance instruction. This is an expansion of a new student technology distribution model which began in the 2016-2017 school year. The usefulness of a chromebook is severely degraded without internet access. Knowing that many of our students have no internet access at home, technology services applied for a ConnectED grant from Sprint in 2016 to provide wireless internet service for students whose families are unable to afford internet service. At that time, the district was awarded 250 lines of service which have been used by middle school students.

With the expansion of the program to loan each student a chromebook device approved to include additional grade levels, technology services applied to Sprint to increase the number of lines of service allocated to the district. Sprint has generously agreed to grant the district an additional 300 lines of service through June 30, 2021. The value of this award is \$432,000. The only cost to the District is the hotspot device, which is a one-time expense to enable the internet connection. The estimated cost of each device is approximately \$112 per hotspot, not including shipping. That equates to an approximate one-time cost \$33,600 plus shipping.

The hotspots will be offered to students who qualify for free lunch under the National School Lunch Program (NSLP). 250 of the hotspots will be allocated to East and West according to the percentage of NSLP eligible students that each high school has out of the total number of NSLP eligible students across both East and West. The breakdown is shown in the table below:

As an example, East has 538 NSLP eligible students. That equates to 38% of the East and West's total eligible NSLP students (538/1399 = .38). That means they will be allocated 96 lines (250 total lines available X .38).

The remaining 50 hotspots will be available to Expo as well as to the district's middle schools to supplement the 250 lines of service they already have available. Parents will be provided with an

application with information they will receive as part of the chromebook project.

# **BOARD-STAFF COMMUNICATIONS**

The success of the school district requires effective communication between the Board and the school staff. Such communication is necessary for the continuing improvement of the educational program and for the proper disposition of issues which may arise. The Board of Education desires to maintain open channels of communication among its members and with staff. However, the basic line of communication with staff will be through the Superintendent.

## STAFF COMMUNICATION TO THE BOARD

All <u>The preferred channel for communications</u> or reports to the Board from building administrators, teachers, or other staff members shall be <u>submitted</u> through the Superintendent or designee. <u>However, this should not discourage staff from engaging</u> with board members on a personal or professional level.

Employee appeals to the board shall be This procedure shall not be construed as denying the right of any employee to appeal to the Board, provided the Superintendent shall have been notified of the forthcoming appeal and that it is processed in accordance with Board policy on complaints or grievances provided the Superintendent has been notified of the appeal.

## BOARD COMMUNICATIONS TO STAFF

All <u>The preferred channel of official communications</u>, policies, and directives of staff interest and concern from the board will shall be communicated to staff members through the Superintendent or designee.

#### VISITS TO SCHOOLS

Individual Board members are encouraged to visit schools to become familiar with the buildings, staff and administration. However, aAny problem issues of concern observed by a Board member should be referred to the Superintendent-immediately.

Individual board members who, in their parental capacity, wish to visit the school(s) or classroom(s) of their child(ren) shall follow the regular procedures for visitors.

## **OUTSIDE CREDITS**

Students who are residents of the Waterloo Community School District may earn four (4) credits from another accredited institution or high school. This does not include credits for students:

- placed in treatment programs and placements by Juvenile Court Services and the Department of Human Services;
- participating in Post Secondary Enrollment Options;
- attending an institution of higher learning through an articulation agreement, such as Hawkeye Community College or University of Northern Iowa.

Students may transfer more than four (4) credits under special circumstances approved by a building administrator. Credits from Waterloo alternative programs are not considered outside credits.

In order to be transferred, outside credits must be taken at educational institutions approved by the Waterloo Community Schools. These include schools approved by the lowa Department of Education, or appropriate regional accrediting association, such as North Central Association of Colleges and Secondary Schools. A Waterloo Schools building administrator must approve the course before the student enrolls in the course. Appeals of the decision of the Principal shall be directed to the Executive Director of Student & At-Risk Services and/or the Executive Director of Supplemental Services. Questions concerning program approval/non-approval may also be directed to the Associate Superintendent for Educational Services.

A student may repeat a class in the summer that was failed during the regular school year. The letter grade earned during the summer will be recorded and included in the student's GPA. Graduate with Required Academics and Diploma (GRAD) credits and credits from Waterloo alternative programs are recorded as letter grades and will be included in the student's GPA.

#### POSSESSION OF WEAPONS OR DANGEROUS OBJECTS BY STUDENTS AND OTHERS

Weapons or other dangerous objects and look-a-likes cause material and substantial disruption to the school environment or present a threat to the health and safety of persons on District premises or property within the jurisdiction of the District or at school events and are thereby prohibited. Such items shall be taken from those who are in possession of or in control of them on District property or premises within the jurisdiction of the District. The parent(s)/guardian(s) of a student found in possession of or control of a weapon<u></u>, or dangerous object or a look-a-like, while on school property or premises shall be notified of the incident.

A weapon means a firearm. Firearm is defined as but not limited to: (a) any weapon (including a starter gun and rifle) which will or is designed to or may readily convert to expel a projectile by the action of an explosive; (b) the frame or receiver of any such weapon; (c) any firearm muffler or firearm silencer; or (d) any destructive device (e.g., explosive, incendiary, or poison gas or otherwise defined by law). Firearms includes guns (e.g., rifles, shotguns) intended to be used for sporting, recreational, or cultural purposes. A student who brings a firearm onto school property or to a school event, or who knowingly possesses a firearm on school property or at a school event, shall be expelled for not less than twelve (12) months. However, the Superintendent has the authority to recommend and the Board has the authority to modify the twelve (12) month expulsion requirement on a case-by-case basis.

Dangerous object is defined as an item capable of producing harm (inflicting death or injury) to oneself or others (e.g., knife, club, chains, razor-blade, dagger, stiletto, switchblade, mace, pepper spray, brass knuckles).

Confiscation of weapon(s), or dangerous object(s) shall be reported to law enforcement officials. A student found to possess or control a weapon or dangerous object will be referred to law enforcement officials and the student shall be subject to disciplinary action that could be suspension or expulsion.

The following situations are exempt from this policy:

- 1. Weapons under the control of law enforcement officials while on school property.
- 2. Persons with express permission of the building principal who display unloaded weapons, other dangerous objects, or look-alikes for educational purposes.
- 3. Persons who carry unloaded rifles, dangerous objects or look-alikes with the express permission of school authorities while participating as a color guard at an event held on school property.
- 4. Persons with express permission of school authorities who carry rifles modified to fire only blank rounds while participating in a gun salute ceremony at an event held on school property such as flag retirement ceremonies, Veteran's Day or Memorial Day observance.
- 5. Air rifles issued by U.S. Army Cadet Command for use in approved Marksmanship Program are permitted in the JROTC storage area and Air Rifle Range.
- 6. The use of look-alike weapons/rifles during Drill Team practice (only if approval on file).

## STUDENT USE OF HANDHELD TECHNOLOGY DEVICES, CELLULAR TELEPHONES, PAGERS, AND OTHER DEVICES

The Waterloo Community School District Board of Educators recognizes the need to provide access to technological resources.

For the purposes of this policy, "Handheld Technology Devices" is defined to include portable two-way telecommunications devices including, but not limited to, cellular telephones (including phones with cameras), laptops, MP3 players, beepers, as well as any new technology developed for similar purposes.

The School Board extends to High School students only, the privilege to possess, display and use Handheld Technology Devices during passing time between classes, during meal times, and before or after school, provided such Handheld Technology Devices are not displayed, activated or used during class time, unless the classroom teacher allows the use of Handheld Technology Devices for educational purposes or to communicate with a student's parent or guardian. [At the Elementary and Middle School levels, use of all electronic devices is prohibited.] Classroom teachers are not authorized to give permission for students to use Handheld Technology Devices to communicate during class time with students outside of the teacher's class. Except as permitted by the classroom teacher, all such devices must be turned off and in a locker, backpack, pocket, or similar enclosure during class time. Exceptions will be made for students with specific needs that require such devices under a "504 Plan," pursuant to Section 504 of the Rehabilitation Act of 1973, as amended; as per their Individual Education Plan "IEP"; and during a medical or security emergency, if a supervising school official is not in communication with emergency responders, or the student is unaware that a supervising school official is in communication with emergency responders. Additionally, exceptions may be made to allow secondary students to use a compatible personal laptop or chromebook computer in lieu of the chromebook issued by the Waterloo Community School District at the discretion of school administration.

The school district will not be responsible for financial charges relating to student Handheld Technology Devices at any time, to include during times of confiscation. Student use of personal Handheld Technology Devices for permitted educational purposes or to communicate with school staff or other students is optional.

The school district will not be responsible for <u>financial charges</u>, loss, damage, destruction, or theft of any electronic device brought to school <u>including during times of confiscation</u>.

#### **BACKGROUND:**

An annual audit is required by Chapter 11.6 of the Code of Iowa. This outside audit is performed through a contracted service. The independent audit must meet minimum state specifications per the Code of Iowa and national specifications as outlined in Government Auditing Standards. The audit includes examining evidence supporting the amounts and disclosures in the financial statements. It features a review of the internal controls the district has established which would permit the timely detection of an error or irregularity. It also focuses on compliance with state laws and the requirements of state and federal granting agencies. The report includes sections on compliance and any recommendations for improvements in the internal control system.

The Finance Committee met with chief auditor, Dennis Muyskens of Hogan Hansen to review the report on April 24, 2018. Also present was Jeff Sommerfeldt, WCSD Business Manager and Deb Jacobs, WCSD Staff Accountant who are instrumental in coordinating the completion of all the audit requirements.

The district has received an unqualified opinion on the audited financial statements for nineteen consecutive years.

#### **BACKGROUND:**

Chapter 24.9 of the Code of Iowa provides for the amendment and increase of certified budgets to permit appropriation and expenditure during the fiscal year covered by the budget of unexpended cash balances on hand at the close of the preceding fiscal year and to also permit appropriation and expenditure of cash anticipated to be available during the year which had not been previously estimated and appropriated for expenditure.

The District Certified Budget is approved under four categories and includes the total of all funds. The four categories are Instruction, Support Services, Noninstructional Programs and Other Expenditures. If activity in any or a combination of all funds causes the total budget to be exceeded, the budget must be amended by board action.

When the Board certified the 2017-18 District Budget, the following categories were set:

No additional property taxes will be required to fund these amendments.
