#### Job Duties:

- 1. Maintain all mechanical and electrical equipment in the building.
- 2. Operate and maintain boilers, which includes water treatment, combustion, air controls and controls on combination gas burners and air conditioners.
- 3. Maintains air compressors, pressure switch, pressure relief valve and bleeding of water from tanks and oils when necessary.
- 4. Maintains and repairs pumps, nozzles, traps, valves, gauges, meters, regulators, filters, master controls, submaster controls and sump pumps.
- 5. Maintains and repairs zoned air supply, smoke detectors, blowers, outside air control, and fire door controls.
- 6. Maintains comfortable rooms heating, cooling, air supply, thermostats, mixing boxes, converters and unit heaters.
- 7. Maintains night controls, clocks governing day and night cycles and control switch.
- 8. Maintains and repairs all exhaust systems.
- 9. Maintains mixers, shredder, crusher, dishwasher and other kitchen equipment and laundry equipment.
- 10. Maintains on a regular basis all filters, belts and bearings, lubricating, bleeding, closing, opening and adjusting of univents and similar equipment.
- 11. On a constant basis assesses equipment and readings to identify potential problems or issues needing attention.
- 12. Tests pool water for chemical content and clarity a minimum of 3 times per day and adds chemicals as necessary.
- 13. Maintains a daily log of all water tests.
- 14. Isolates any faulty device and takes appropriate measures for the continuation of school by repairing the device or obtaining qualified assistance when there is a problem.
- 15. Performs minor electrical repairs such as light switches, ballasts, wall receptacles, etc.
- 16. Performs duties within state and local code requirements.
- 17. Follows safe working procedures.
- 18. Cleans area after work is completed.
- 19. Performs snow removal duties as needed.
- 20. Performs duties during auditorium events as necessary.
- 21. Perform other duties as assigned.
