First Student Transportation in collaboration with the Boys & Girls Clubs of the Cedar Valley and the Waterloo Community School District (WCSD) will provide after-school transportation from your child's school to the club. Students from the following school sites will be transported from their school to the Boys & Girls Club located on Lime Street; **Carver, Central, Cunningham, Fred Becker, Hoover, Irving, Lincoln, Lou Henry, Lowell, Kingsley, Kittrell, and Orange**. Students from the following school sites **Poyner, Bunger & Highland** will be transported to the Evansdale/ Elk Run location. Students from the following school site **West High School** and any student from the schools listed above that are **13+** will attend the Teen Center located on 4th Street.

Transportation will be provided Monday through Friday (as space is available) and will include the following guidelines:

1. A copy of this permission slip **must be** on file with WCSD and First Student **before** a child can be allowed to ride the bus to the Club. This should be completed each school year.
2. All students riding the bus to the Club **must be current members** of the Boys & Girls Club of the Cedar Valley.
3. It will be your child's responsibility to be at the bus stop at the appropriate time of pick-up. Elementary buses will depart from the school at 3:52 pm. Middle and High School buses will depart at 2:52 pm. The bus will wait 7-8 minutes after school is let out and **will not** return to pick-up students who miss the bus.
4. Any student not observing First Student or WCSD policy; or the Club's rules may be suspended or dropped from the program.
5. Any bus suspensions will also result in a suspension from the Club for the same period of time.
6. All students will be required to stay seated while riding the bus or van.
7. Students attending the Lime Street Location must be picked-up from the Club by 7:00 pm.
8. **Poyner, Bunger & Highland** students ages 12 and under will attend the Evansdale/ Elk Run location. Pick-up time for Evansdale is 7:00 pm.
9. Students ages **13+** will attend the Teen Center located at 815 E. 4th St, Waterloo, IA. Pick-up time for the Teen Center is 8:00 pm.
10. The Boys and Girls Club will be canceled if school is canceled.

I have read and understand the guidelines and rules for participation in the Boys & Girls Club of the Cedar Valley after School Transportation program. I give permission for my son/ daughter to participate in the After School Transportation program with the Club and First Student and I agree not to hold either of these parties or any other agency assisting with this program responsible in case of accident or injury.
